Judging Process and Criteria. Judges will read and score all entry forms, considering any supporting materials submitted. Judges will be asked to give a score for each question within the entry form, as listed in the bullet points below.

These will be combined to give an overall score for each entry. All judges' scores will then be combined and the highest-scoring entry will be selected as our grand prize winner.

All entries will be scored on a scale of 0-100.

Are submitted blurbs clear in telling your story as an API Innovator with the help of Kong solutions? Up to 20 points.

Do submitted blurbs feature:

- Why you love APIs/ how APIs have allowed you to innovate? Up to 20 points.
- Why you chose Kong as an API solution/ Outline the benefits and impacts from utilizing Kong as a solution, including data points where possible. Up to 20 points.
- A summary of your project/ use case and what makes it recognition worthy. Up to 20 points.

Judges will consider the creativity, structure, presentation and clarity of each entry. Up to 20 points.

If appropriate you may include up to three pieces of supporting materials.

Submitted blurbs do not need to directly mention which version of Kong you are using

- If you are an Enterprise level customer, we would love to hear that.
- If you are an OSS user, your story can speak more broadly to the groundbreaking work you are doing as an API Innovator with the help of Kong solutions

The entry with the highest total score will be the winning entry. In the event of a tie in overall score, the entry with the highest creativity points will win, and in the event of a continued tie, the entry with the highest points for product promotion and then adherence to theme will win.
